In Accordance with the following bylaw, a notice of meeting was sent to the current members of record as of January 31 2018 on February 5th, 2018

10. Notice of Members Meeting

Notice of the time and place of a meeting of members shall be given to each member entitled to vote at the meeting by the following means:

- 1. by mail, courier or personal delivery to each member entitled to vote at the meeting, during a period of 21 to 60 days before the day on which the meeting is to be held; or
- 2. by telephonic, electronic or other communication facility to each member entitled to vote at the meeting, during a period of 21 to 35 days before the day on which the meeting is to be held.
- 3. in the event the corporation has more than 250 members, by publication at least once in each of the three weeks immediately before the day on which the meeting is to be held in one or more newspapers circulated in the municipalities in which the majority of the members of the corporation reside as shown by their addresses in the register of members;





FINDINGS


What Listeners Value

- We provide a great service to the community


What Surprised Listeners

 The need for donations on an ongoing basis – that advertising was not enough








